

To put this into reality, UNODC launched an ambitious Global Programme to help countries achieve a sustainable impact on the rule of law. Made possible thanks to the support of the State of Qatar, the Global Programme focuses on four interrelated components:

Resilient and transparent institutions: Strengthening judicial integrity and preventing corruption in the justice system.

Fair, humane and effective criminal justice systems: Fostering the rehabilitation and social integration of prisoners to provide a new chance in life.

Youth crime prevention: Preventing youth crime through sports-based programmes and life skills training.

Education for Justice: Supporting the integration of crime prevention and the rule of law into all levels of education.

In Mexico, it increased 27% in the last year. In 2020, 260,067 emergency calls for violence against women were reported, during the same year, official data reported 940 femicides and 2,783 intentional homicides of women (SESNSP, 2020).

Diploma in prevention, research of femicide and police action

In this context, LPOMEX created in 2016 the Project "Strengthening Program for the Security of Groups in Situation of Vulnerability" along with the support of the Mérida Initiative, and the Secretariat of Security and Citizen Protection, we have been trained 13,000 police on care victims. In 2019, the "Diploma in prevention, investigation of femicide and police action" was created to strengthen the capacities of prevention and investigation of cases of femicide. We have been training more than 100 police officers in technical procedures combined with an ethical reflection on police action's impact to save lives.

The UNODC Global eLearning Programme strengthens the capacity of Member States by better addressing diverse human security and health challenges such as wildlife crime, human trafficking, drug abuse, HIV, gender-based violence, and terrorism.

The Programme produces and delivers online training through innovative hi-tech methodologies in order to enhance law enforcement response to global human security challenges through self-paced and instructor-led courses on UNODC eLearning platform, which is currently reaching over 100,000 member state Officials globally.

Wildlife and forest crimes are serious transnational organized crimes. Criminal groups use the same routes and techniques to traffic wildlife and other illicit commodities, exploiting gaps in national law enforcement and criminal justice systems. These crimes threaten biodiversity, good governance, economic development and livelihoods, and are interlinked with other transnational organized crimes, money-laundering and corruption.

The International Consortium on Combating Wildlife Crime (ICCWC), founded in 2010, is the collaborative effort of five intergovernmental organizations working to strengthen criminal justice systems and provide coordinated support at national, regional and international level to combat these crimes with a view to ensuring that these offences are effectively and collectively addressed. ICCWC includes the CITES Secretariat, INTERPOL, UNODC, the World Bank and the World Customs Organization.




