

「受刑者に対する釈放時アンケート」について（令和 5 年度分）

刑事施設の運営の実情に対する国民の理解を深めることを目的として、令和 5 年度に実施した「受刑者に対する釈放時アンケート」の集計結果を公表しますので、お知らせします。

1 内容

行刑改革会議の提言を受け、矯正行政の透明化、処遇環境の充実化等を推進するための一方策として、平成 17 年 4 月から、出所受刑者を対象として釈放時アンケートを実施しています。

釈放時アンケートは、受刑者の釈放時の感想等を集計し、刑事施設の適正な運営を図るための資料として活用するとともに、その結果を公表し、刑事施設の運営の実情に対する国民の理解を深めるための資料として活用するものです。

2 調査期間

令和 5 年 4 月 1 日から令和 6 年 3 月 3 0 日

3 対象者 15, 2 4 0 人

※ 上記の期間中に、刑事施設を釈放となった受刑者

4 有効回答数（回答率） 14,7 9 7（97.1%）

（男性：13,140人，女性：1,657人）

※ 対象者のうち、アンケートの実施を拒否した者は除いた。

※ 1項目でも有効な回答があれば有効回答数に計上している。
