

## For Victims Requesting Information on Persons under Medical Treatment and Supervision

In accordance with requests from victims, information is provided on persons concerning the stage of treatment (in-patient treatment, out-patient treatment, end of treatment) and status of in-patient treatment of perpetrators.

### Those who can petition for the provision of information

- ① Victims of acts prescribed in the Act on Medical Care and Treatment for Persons Who Have Caused Serious Cases Under the Condition of Insanity
- ② Legal representatives of ①
- ③ Spouse, lineal relatives or siblings when ① died or suffered serious physical or mental harm
- ④ Attorneys commissioned by ①~③

### Content of the information provided

- ① Name of the perpetrator
- ② The stage of treatment (in-patient treatment, out-patient treatment, end of treatment) and the date of commencement or end of the treatment
- ③ Name, location and contact information of the probation office which is(was) in charge of the case
- ④ Contact with the perpetrator by the probation office during out-patient treatment (the number of interviews during the last 6 months)

### Procedure

- ① Please ask the chief of the rehabilitation coordinator division at the nearest probation office if you would like to receive information. (Please refer to the list of probation offices nationwide on the back. Hokkaido is divided among the Sapporo Probation Office, Hakodate Probation Office, Asahikawa Probation Office and Kushiro Probation Office. So please confirm which probation office has jurisdiction over the area where you live. In addition, please be aware that the Sakai Branch of the Osaka Probation Office and each probation office representative office cannot handle requests.) Also, when reviewing a request for the provision of information, we confirm the identity and eligibility of the requesting person (driver's license, individual number card (excluding notification card), etc).
- ② After confirming the content of information to be provided at the probation office, the information will be provided orally or in writing.
- ③ Do not inappropriately share the information provided by this procedure to a third party. In addition, information may not be provided to you if doing so is considered inappropriate.
